

Kankakee Trinity Academy: International Enrollment Policies

This policy is the official policy of Kankakee Trinity Academy, and it pertains specifically to international students who are enrolled in the school on an F-1 visa.

Policy Statement

Kankakee Trinity Academy (KTA) has established the following policy for tuition refunds of international student fees as noted below and in conjunction with the Options Group International Student Application Terms and Conditions, which is supplied and posted as part of the international student enrollment and re-enrollment processes.

On Student Withdrawal: An International student or natural parent may voluntarily withdraw from Kankakee Trinity Academy at any time. Should this occur, the student and/or natural parent would not be entitled to a refund of any amount whatsoever. Parents' obligation to pay the charges for tuition, accommodation and related fees for the entire year is unconditional and no portion of such charges so paid or outstanding will be refunded or canceled notwithstanding the subsequent absence, withdrawal, or dismissal from the school of the named student. The school cannot refund tuition or cancel unpaid obligations if a child chooses or is forced to withdraw 90 days prior to arrival and/or upon arrival to the United States. Students who re-enroll for additional academic years will not be entitled to a refund once their return for a subsequent academic year has been confirmed and payment has been made.

On Student Transfer: In addition to a strict no refund policy, in accordance with Sevis reporting obligations, the students I-20 will be terminated as of the last date of attendance at the school, if school transfer information has not been provided by the student or student representative. Cases of voluntary student transfer post arrival in the United States or 60 days prior to the start date of the academic year are considered a withdrawal.

All international Students are subject to the administration and instructional staff of Kankakee Trinity Academy and that all matters involving the student's enrollment shall also be governed by Kankakee Trinity Academy's International Student enrollment policies in addition to those terms and conditions as listed as part of the Options Group common application.

Host family placements and assignments are at the exclusive domain of the school and are subject to change due to host family and/or school discretion. Voluntary departure or non-acceptance of a placement will not result in a refund of unused accommodation fees. In these circumstances, no refunds will be considered or issued whatsoever.

On termination by the school: Should the termination of enrolment be due to student misconduct, expulsion, or failure to provide true and accurate information on enrollment, there will be no refund whatsoever of tuition, accommodation, enrollment, application or any additional fees.

Kankakee Trinity Academy also reserves the right to terminate a student's participation in the school for any student whose conduct may be considered detrimental or incompatible with the interest and security of the school. If this decision is undertaken, the student and his/her parents or legal guardians will have no right to a refund of any fees whatsoever. Kankakee Trinity Academy reserves the right to, directly or indirectly, cancel, change, or substitute in emergencies, or even due to normal circumstances change, those parts of the program whose alterations may be considered necessary such as host family assignment or available coursework.

Tuition Insurance: Parents and Students are encouraged but not obligated to consider independently purchasing Tuition Reimbursement Insurance at their own expense to protect their education investment. Similar to home or automobile insurance, natural parents can insure your child's education to protect against the unexpected. Tuition insurance, also referred to as a tuition refund plan, reimburses certain education-related expenses if your child is forced to withdraw. This type of insurance is typically geared toward higher education, but some insurance programs cover K-12 as well. Kankakee Trinity Academy does not provide or sell this type of insurance product as it is the natural parents responsibility to locate, understand and purchase this type of insurance under their own volition.

Notice: Terms and conditions can be modified at any time without notice. Terms and Conditions are supplied to parents or guardians upon request and/or by the agency in their home nation.
